Policy

Definitions

Personal attribute: a personal attributes that is protected by State or Commonwealth antidiscrimination legislation. These attributes include but are not limited to: race, disability, sex, sexual orientation, gender identity, and religious belief or activity.

Reasonable adjustment: a reasonable adjustment is a measure or action taken to assist all students to participate in their education on the same basis as their peers.

Reasonable adjustments for students with disabilities

Bendigo Senior Secondary College also understands that it has a special obligation to make reasonable adjustments to accommodate students with disabilities. Reasonable adjustments will be made through our Student Support Group processes. They will be developed in consultation with the student, parent/carer, teachers and, if appropriate, treating practitioners.
